

**FANDANGO'S ESCAPE THE OFFICE SWEEPSTAKES ("Sweepstakes")
OFFICIAL RULES ("Official Rules")**

NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

YOU MUST EITHER BE 21 YEARS OF AGE OR OLDER, OR 18 YEARS OF AGE OR OLDER AND ACCCOMPANIED BY SOMEONE 21 YEARS OF AGE OR OLDER, TO WIN THE GRAND PRIZE

BY SUBMITTING AN ENTRY TO THIS SWEEPSTAKES DURING THE SWEEPSTAKES PERIOD, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT. SO READ THEM CAREFULLY BEFORE ENTERING. AMONG OTHER THINGS, THIS CONTRACT INCLUDES INDEMNITIES FROM YOU TO THE RELEASED PARTIES AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

SWEEPSTAKES PERIOD: The Sweepstakes begins at 6:00 AM Pacific Time ("PT") on January 6, 2026, and ends at 11:59 PM PT on February 1, 2026 (the "Sweepstakes Period"). The computer clock of the Administrator is the official time-keeping device in the Sweepstakes. By participating, participants ("Participants") agree to be bound by these Official Rules and the decisions of Fandango Media, LLC ("Sponsor"), which are binding and final on matters relating to this Sweepstakes.

ELIGIBILITY: Sweepstakes is open only to (i) legal residents of the fifty (50) United States and District of Columbia (excluding residents of Puerto Rico or other U.S. Territories) (the "Eligibility Area"), (ii) who enter the Sweepstakes from within the Eligibility Area, and (iii) who are at least eighteen (18) years of age at time of Sweepstakes Entry (as defined below), provided, however, that to be eligible for the Grand Prize, the winner must be twenty-one (21) years of age or older, or accompanied by someone twenty-one (21) years of age or older. Employees, officers and representatives of the Sponsor, Southern Made Services, LLC (the "Administrator"), ABC, Inc., doing business as, Walt Disney Studios Motion Pictures ("WDSMP"), Twentieth Century Fox Film Corporation ("TCFFC"), Searchlight Pictures ("Searchlight", together with WDSMP and TCFFC "Disney"), and each of their respective parents, affiliates, subsidiaries, sales representatives, web-design, advertising, marketing, fulfillment, judging and promotion agencies, or other agencies involved in the administration, development, fulfillment and execution of this Sweepstakes, and each of their respective immediate family members or household members are not eligible to participate in the Sweepstakes. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses, and their respective spouses. "Household members" shall mean people who share the same residence at

least three (3) months a year, whether or not related. Winning the prize is contingent on fulfilling all requirements in these Official Rules. All federal, state, and local laws and regulations apply. Void where prohibited or restricted. All Sweepstakes Entries are the property of the Sponsor.

HOW TO PARTICIPATE: During the Sweepstakes Period, there are two (2) ways to participate. **1) Entry with Purchase:** Purchase one (1) ticket during the Sweepstakes Period on www.fandango.com ("Website") or the Fandango app ("App") to see *Send Help* at a participating Fandango theater and get one (1) entry ("Purchase Entry"), or purchase (2) tickets during the Sweepstakes Period on the Website or App to see *Send Help* at a participating Fandango theater in a single transaction and get two (2) Purchase Entries. **2) Alternate Means of Entry:** To receive two (2) Sweepstakes Entries without making a purchase (each, an "AMOE Entry", and collectively with Purchase Entries, "Sweepstakes Entries"), visit <http://EscapeTheOfficeSweepstakes.entertowinprizes.com> and enter your full name, complete address (no P.O. boxes permitted), phone number (including area code), and email address during the Sweepstakes Period.

Sweepstakes Entries generated by script, macro or other automated means, and Sweepstakes Entries by any means which subvert the entry process, are void. By submitting a Sweepstakes Entry, you agree to these Official Rules and are willing provide your information to the Sponsor and the Administrator. Sweepstakes Entries become the property of the Sponsor and will not be returned.

There is a limit of two (2) Sweepstakes Entries per person, regardless of entry method, using only one (1) email address. Sweepstakes Entries received from any person in excess of the stated limitation, or which are incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost or misdirected, will be void. Subsequent attempts made by the same individual to submit multiple Sweepstakes Entries by using multiple or false contact information or otherwise may be disqualified.

Any and all information provided in connection with this Sweepstakes is subject to the Sponsor's Privacy Policy available at www.fandango.com/terms-and-policies. By entering in the Sweepstakes, Participants hereby agree that the Sponsor may collect and use their personal information submitted with their Sweepstakes Entry. Among other things, the information Participants provide may be used to send company updates and announcements from the Sponsor concerning the company and its products. At the time of entry, Participants may be given the opportunity to opt-in to receive further communications from the Sponsor. Participants are not required to opt-in and opting in will not improve your odds of winning.

SWEEPSTAKES PRIZE DRAWING & WINNER NOTIFICATION: Winner is subject to verification of eligibility requirements, including verification of age. The potential winner of the Grand Prize (defined below) is referred to herein as the "Winner".

The potential Winner will be selected in a random drawing held on or about February 2, 2026. Winner will be contacted via email on or about February 2, 2026. The potential Winner will be required to acknowledge receipt of Winner notification within three (3) days and in addition, (i) Winner will need to execute and return an affidavit of eligibility, a taxable income form, a liability release, and where lawful, a publicity release, all within three (3) days of date of issuance of such notification email, and (ii) Winner will need to provide their complete mailing address. If such documents or information are not returned within the specified time period, the Grand Prize notification is returned as undeliverable, the Sponsor or its agent is unable to contact a potential Winner, a potential Winner declines the Grand Prize for any reason prior to award, or a potential Winner is not in compliance with these Official Rules, the Grand Prize will be forfeited and, at the Sponsor's discretion, an alternate Winner may be selected. The Sponsor reserves the right not to award any Grand Prize in the event the Sponsor is unable to identify and confirm a Winner after attempting to contact an alternate potential Winner. Sponsor is not responsible for any cancellations, delays, diversions, or substitutions, or any act or omission whatsoever with respect to any Grand Prize.

Odds of winning will depend on the number of qualified Sweepstakes Entries received during the Sweepstakes Period.

GRAND PRIZE (1): There is one (1) grand prize ("Grand Prize") available to be awarded to one (1) Winner. Winner will receive a four (4) day, three (3) night trip for Winner and one (1) guest ("Guest") to Lāna'i. The Grand Prize includes round trip coach class airfare for Winner and Guest to and from a state capital city airport near the Winner's home and Lāna'i Airport; hotel ("Hotel") accommodations (one (1) room, double occupancy); and select ground transportation. **The Approximate Retail Value ("ARV") of the Grand Prize is \$4,999.** ARV is estimated for purposes of these Official Rules only.

Grand Prize is for Winner and Guest, and no additional family members or guests are permitted in the Grand Prize. ARV of Grand Prize may vary depending upon the points of departure, ground transportation, and/or airline fare fluctuations; any difference between stated ARV and final ARV of Grand Prize or actual fair market value will not be awarded. Grand Prize consists only of the elements expressly set forth above; no other elements or expenses (including, without limitation, insurance, unspecified meals, unspecified ground transportation, baggage, gratuities, incidentals, souvenirs, gasoline, car rental, etc.) are included in the Grand Prize and all such additional expenses are the sole responsibility of Winner. Once issued, travel tickets are nontransferable and may not be reissued. Open tickets may not be issued, and stopovers are not permitted. Sponsor will not replace any lost, mutilated, or stolen tickets. Sponsor reserves the right to substitute the Grand Prize for one of equal or greater value. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in promotional materials and the terms and conditions of the Official Rules, the Official Rules shall prevail and govern.

Winner and Guest travel at their own risk.

Winner and Guest are responsible for all applicable federal, state, local sales and income taxes and any costs, expense(s) or fees whatsoever in connection with the Grand Prize not specifically provided herein. In the event that, for reasons beyond their control and not related to the Winner, the Sponsor or Disney is unable to award any Prize as described in these Official Rules (including if the designated Grand Prize should become unavailable for any reason), the Sponsor will substitute the Grand Prize with another prize of equal or greater value at its sole discretion. The Grand Prize is non-assignable and non-transferable and is not redeemable for cash and no substitution will be made except as provided herein at Sponsor’s or Disney’s sole discretion. If a selected Winner is unable to accept a Grand Prize in its entirety for any reason, the selected Winner will forfeit the Grand Prize, and the Grand Prize may be awarded to an alternate Winner. All Sweepstakes Entries and potential Winner are subject to verification by the Sponsor and the Administrator, whose decisions are final and binding. Proof of identity and/or residence reasonably satisfactory to the Sponsor and/or the Administrator may be required to verify eligibility. The Sponsor and the Administrator have the right to determine Sweepstakes eligibility in their discretion; all decisions concerning Sweepstakes eligibility are final. Any effort to circumvent the Sweepstakes’ limits, requirements, or other terms (including, but not limited to, providing fictitious information or concealing identity or location) voids submissions and disqualifies person from participating in the Sweepstakes.

By participating, Participants accept and agree to: (i) be bound by these Official Rules, any applicable rules, terms of entry, or terms and conditions related to any Grand Prize elements (including, but not limited to, non-disclosure agreements as may be required), and all applicable laws and the decisions of the Sponsor, which shall be final and binding in all matters; (ii) waive any rights to claim ambiguity with respect to the Official Rules; and (iii) waive all of his/her rights to bring any claim, action, or proceeding against any of the Released Parties for any Losses arising out of, or related to, this Sweepstakes. Released Parties are not responsible or liable for Sweepstakes Entries that are entered by other than human means (such as by an automated computer

program or any non-human mechanism, entity, or device), in excess of the stated limit, or for Sweepstakes Entries that are late, forged, destroyed, lost, misplaced, stolen, misdirected, tampered with, incomplete, deleted, damaged, garbled, or otherwise not in compliance with these Official Rules, and all such Sweepstakes Entries will be disqualified, or emails or other errors or difficulties of any kind whether human, technical, electronic, mechanical, network, seeding, computer, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of Grand Prize redemptions, emails, Sweepstakes Entries, the announcement of the Winner, or in any Sweepstakes-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by Website or App users, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes. Released Parties are not responsible for injury or damage to Participant's or to any other person's computer related to or resulting from participating in this Sweepstakes or downloading materials from or use of the Website or App. Persons who tamper with or abuse any aspect of the Sweepstakes or who are in violation of these Official Rules, as solely determined by the Sponsor, will be disqualified and all associated Sweepstakes Entries will be void. Should any portion of the Sweepstakes be, in the Sponsor's sole opinion, compromised by non-authorized human intervention or other causes which, in the sole opinion of the Sponsor, corrupt or impair the administration, security, fairness or proper play or submission of Sweepstakes Entries, the Sponsor reserves the right at its sole discretion to suspend, modify or terminate the Sweepstakes. If terminated, at its discretion, the Sponsor reserves the right to select the potential Winner from all eligible, non-suspect Grand Prize claims received prior to action taken or as otherwise deemed fair and appropriate by the Sponsor. In no event will the Released Parties be liable for more than the stated number of prizes in these Official Rules. CAUTION: ANY ATTEMPT BY AN INDIVIDUAL TO DELIBERATELY DAMAGE THE WEBSITE OR APP OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS, AND SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSOR RESERVES THE RIGHT TO DISQUALIFY SUCH INDIVIDUAL AND SEEK ANY AND ALL REMEDIES AVAILABLE FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT PERMITTED BY LAW. Participants, by participating, agree that the Sponsor, the Administrator, Disney, and each of their respective parents, affiliates, subsidiaries, advertising and Sweepstakes agencies, promotional partners, and all of their respective officers, directors, employees, shareholders, representatives and agents (collectively, "Released Parties") will have no liability whatsoever for, and shall be held harmless by Participants against, any Losses resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of a Grand Prize (including any travel or activity related thereto) or participation in this Sweepstakes. Any controversy or claim arising out of or relating to these Official Rules, or the Sweepstakes shall be exclusively settled by binding arbitration in accordance with the commercial arbitration rules of the American Arbitration Association, in Los Angeles County, California. Any such controversy or claim shall be arbitrated on an individual basis and shall not be consolidated in any arbitration with any claim or controversy of any other party.

CHOICE OF LAW AND JURISDICTION: All federal, state, and local laws and regulations apply. Void where prohibited by law. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any Participant and the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the state of California without giving effect to any choice of law or conflict of laws rules (whether of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than California. Any action seeking legal or equitable relief arising out of or relating to the Sweepstakes or these Official Rules not subject to arbitration shall be brought only in the courts of the State of California, in the County of Los Angeles. You hereby irrevocably consent to the personal jurisdiction of said courts and waive any claim of forum non-conveniens or lack of personal jurisdiction.
